ANS: D

Any drug for which a clinical claim is made must be registered by the TGA.

ANS: B

The quality use of medicines (QUM) involves rationalising government policies and ensuring that medicines are used safely and effectively.

ANS: D

ANS: B

Parenteral administration refers to the administration of drugs by injection.

ANS: D

For patients to be 'compliant' with therapy, they must follow all therapeutic advice given to them.

ANS: A

ANS: B

Schedules 2 (pharmacy medicines), 3 (pharmacist-only), 4 (Prescription-only) and 8 (controlled drugs) include drugs used medically.

ANS: B

Drug scheduling is not based on the manufacturer process. Classification depends on formulation, action, toxicity and potential for abuse.

ANS: D

Justice affords all people, despite socioeconomic status, the right to equal healthcare benefits.

15. The ethical principle of beneficence involves:

- C. Doing good as part of duty of care
- D. Doing no harm as part of duty of care

ANS: C

Beneficence underpins the duty of care owed to patients and clients by health professionals to meet required standards of care delivery.
