Chapter 02: Advanced Practice Roles, High Performing Interprofessional Teams, and the IT-HI Model

1. Interprofessional Team for Health Informatics (IT-HI) Model is an evolved version of:

- a. Technology Informatics Guiding Education Reform (TIGER) Initiative
- *b. Nursing Education for Healthcare Informatics (NEHI) Model

Answer: IT-HI Model is an evolved version of Nursing Education for NEHI Model. TIGER Initiative recommended nursing schools to engage nursing students and practicing nurses into digital healthcare. QSEN addresses competencies related to patient-centered care, teamwork and collaboration, evidence-based practice (EBP), quality improvement (QI), safety, and informatics. HITECH Act promotes adoption of electronic health record (EHR) systems among healthcare providers.

Answer: FTC oversees the reimbursement structure for the payment of healthcare services. FDA is responsible for protecting and promoting public health food safety, prescription and over-the-counter drugs, vaccines, and medical devices. AANP provides nurse practitioners a unified way to network and advocate their issues. National Center for Interprofessional Education and Practice provides educational resources, networking opportunities, grant funding sources, and innovative approaches in support of interprofessional practice and education.

4. Which of the following advanced-level healthcare clinician helps build or restore vocational, homemaking, and daily living skills, along with general independence, to a person with disabilities or developmental delays?

Physical therapists assess, plan, organize, and participate in rehabilitative programs that improve mobility, relieve pain increase strength, and improve or correct disabling conditions resulting from disease or injury. Advanced practice registered nurses have graduate-level education, recognized specialty nursing certificate, and are licensed for an APRN role. Behavioral health professionals are licensed to address a patient's behavioral issues.

Dietitians and Nutritionists counsel individuals and groups, conduct nutritional research, and supervise activities of a department providing quantity food services. APRNs implement decisions and activities, engage in evaluation initiatives, and ensure consideration and inclusion of the healthcare consumer's perspectives, information, contributions, and requests.

data, information, knowledge, and wisdom between the clinical and information technology personnel and sectors. The new informatics-oriented domains added to the components of nursing practice provide the foundation, rationale, for the competency-based development of technology within the nursing education.

Occasions when students from two or more professions in health and social care learn together during all or part of their professional training with the object of cultivating collaborative practice for providing client- or patient-centered care is known as interprofessional education (IPE).
