Suggested answer: Sample response: The interpersonal justification looks at the quality of interactions among participants during the research process. The experiential justification relates to the congruence with the lived experience of participants in the program and in the evaluation process.

Compare and contrast neo-pragmatism and pragmatism in research paradigms.

Suggested answer: Sample response: Pragmatism is divided in history by early pragmatism and neo-pragmatism. Both belong to the pragmatic paradigm in research; pragmatism is the over-arching belief, and the neo-pragmatism is a more current updated understanding of the philosophies. They believe that the use of a single scientific method could not truly align with the real world and that the best method is one that most closely aligns with what is being studied. Neo-pragmatists go beyond emphasizing common sense, practical thinking, and mixed methods research.

Suggested answer: Sample response: Maxwell believes the use of qualitative methods are important because it takes broader contexts into account, including social and cultural aspects. It provides researchers with more understanding of complex ideas. An example of a qualitative method would be doing one-on-one interviews with students to provide rich qualitative data.

Suggested answer: Sample response: Constructivists are concerned with reality and how it can be measured objectively given the social and individual nature of humans. In this study, you would interview teachers to obtain more qualitative information about the program/study. You would want to know what the teachers thought of the program and how exactly they used the program within their classroom. Using case studies or first-hand accounts of this program, how well it was implemented, and the success or failure seen by teachers or others are techniques that can be used.

Suggested answer: Sample response: The theoretical foundation for the transformative paradigm in research includes the use of mixed methods, qualitative, feminist, and disability research, participatory action research, critical ethnography, culturally responsive research as well as international development. One specific philosophical basis is participatory action research that focuses on marginalized communities and the problems they face. One example may be looking at family and community involvement in poverty-stricken areas. Meeting with school faculty, parents, students, and those within the community and establishing programs or activities to increase this involvement.

Transformative paradigm is a good paradigm, but Indigenous fits better. Important factors to remember with this paradigm is that it is important to have high community involvement between researchers and the Inuit population. It is important for researchers to build relationships with the community members and to fully understand the contextual, relational, and culturally connected reality of this Indigenous group.*

Focusing solely on rigorous methodology like legislation is pushing for can have lasting effects on schools*
