Define social constructionism, and discuss one historical or cross-cultural variation in gender that exemplifies the social constructionist approach.

Suggested answer: Sample response: Answers may vary. Students could discuss the Greek concept of one hierarchically ordered sexual category in which women are lower in status than men. This historical example of a unilateral rather than bilateral system supports the social constructionist approach.

Compare and contrast the biosocial approach and strong social constructionist approach to gender. What are their key similarities and differences?

Suggested answer: Sample response: Answers may vary. Table 1.1 compares the biosocial and strong social constructionist approaches. Students should discuss the position of each approach on sexual dimorphism, relationship between sex and gender, and stance on intersex and transgender people.

Q48. [Essay] · Cognitive Domain: Analysis

Define sexual dimorphism. How is this concept central to the biosocial approach? How have social constructionists challenged sexual dimorphism?

Suggested answer: Sample response: Answers may vary. Students should explain that sexual dimorphism refers to physical and genetic distinctions that categorize people into one of two discrete categories—male and female. Based on characteristics, people are assigned to one of the two categories. Social constructionists argue that not all people fit into one of the categories. Students should cite the existence of intersex people as evidence.

What does the term “intersex” mean? How do intersex individuals pose a challenge to conventional beliefs about sex and gender?

Suggested answer: Sample response: Answers may vary. Students should define the term intersex and discuss the various forms. They should introduce the term sexual dimorphism and explain that intersex individuals do not fit into the male/female sex categories.

Analyze and explain the statement “our social beliefs can have a crucial impact on bodies.” Which approach is supported by this claim?

Suggested answer: Sample response: Answers may vary. Students should refer to studies presented in the section “Gender and Bodies”: social beliefs that have affected bone mass, brains, and muscles. Students should explain how the effect of social beliefs on the body is support for the social constructionist approach.

Explain how the Thomas principle helps in understanding the social construction of reality as it relates to gender.

Suggested answer: Sample response: Answers may vary. The best way to help us understand the social construction of reality as it relates to gender is to use the Thomas principle, from W. I. and Dorothy Thomas, which states, “If people define situations as real, they are real in their consequences.” Take the gender binary, for example. In many places, like the United States, people believe that there are two and only two types of people in the world—women and men. This belief in two discrete categories that describe the gender of everyone is what we call the gender binary. Many people believe the binary is natural and universal. There have always been two types of people—males and females—and there always will be.

Discuss why the categories of male and female do not accurately describe the reality of physical bodies.

Suggested answer: Sample response: Many would argue that the diversity in our physical bodies is greater than our categories would lead us to believe. They might go so far as to argue that our belief in how bodies should be gets in the way of our perceiving the way bodies actually are. Because we believe that everyone should have a penis or a vagina, we tend to ignore the many cases of people who have both. Because we believe that the gender you’re assigned at birth should line up with the gender you live, we stigmatize transgender people who violate these norms.

Using examples, describe the three main goals for studying gender.

Suggested answer: Sample response: First, build an understanding of the ways in which gender is socially constructed in a global, historical, and intersectional context. One fundamental truth about gender that those who study this topic have arrived at is that gender varies a great deal based on where, when, and who you are. The second goal is to debunk any ideas about what is normal and abnormal regarding gender. Do this through looking at gender globally and by being intersectional—by placing the experiences of people of color, gay and lesbian people, transgender people, and working-class people at the center rather than at the margins of our inquiries. The particular language used to talk about different experiences and places in the world is important. The term Western assumes not only a geographic centering but also an economic and social one.
