A White woman, Black man, and Hispanic man all are found guilty of murder under the same circumstances. Based on research, compare and contrast the likely harshness of their expected sentences.

Suggested answer: Sample response: In the current U.S. criminal justice system, imprisonment rate is strongly affected by race and gender. In general, a White woman would likely receive a lesser sentence than a Black or Hispanic man. A Hispanic man would generally serve less time than a Black man. Research shows that a Black offender who kills a non-Black victim has the highest likelihood of being sentenced to death.

Q76. [Essay]

Compare and contrast white-collar crimes with street or property crimes in terms of their potential for widespread damage.

Suggested answer: Sample response: White-collar crime covers a broad range of criminal activity including insider trading, bank fraud, bribery, and Ponzi schemes. The scope of these crimes is often more damaging to an individual than street or property crimes as the white-collar criminal may steal a victim's retirement fund or wipe out their bank account. Furthermore, white-collar crime has the ability to impact our economy or bring large corporations down. In many ways, this is more damaging to a way of life than a street or violent crime.

Q77. [Essay]

Compare how the FBI's legal definition of rape has changed over the past couple of decades. Analyze the implications of these changes in defining and reporting rape statistics on law enforcement practices.

Suggested answer: Sample response: The definition of rape has been expanded over the past few decades. The FBI has changed their definition to broaden the behaviors that constitute rape and to include men and boys as possible victims of rape. In addition, the FBI removed the word "forcibly" from their definition to reflect the contemporary understanding of rape. The new definition focuses more on lack of consent, including incapacitation of the victim, rather than force. This change has broadened the scope of what constitutes rape and improved the accuracy of rape statistics reported. The changes have led to more comprehensive data collection and reporting.

Q78. [Essay]

Discuss the role of the victim in the criminal justice system. How has it changed over the past several decades?

Suggested answer: Sample response: Traditionally, the victim was ignored in the road map of criminal justice. In recent years, however, the victim has played a more involved role in the prosecution of people who are incarcerated. Victims are now often provided access to a victim advocate that helps them work with the police and government to assist in the prosecution of the person who is incarcerated. In addition, victims have expanded rights when it comes to being notified about the case in which they are involved. Formerly, victims were not informed or protected during this process, but now they have an advocate that will inform them of their rights from the beginning of the process until the end of the trial.

Q79. [Essay]

Edwin Sutherland and Paul Tappan held two different views on what makes a criminal. Compare and contrast the views of Sutherland and Tappan.

Suggested answer: Sample response: Sutherland did not agree with the legal definition of criminal behavior. He believed that the conviction of a criminal act was an unnecessary condition for determining whether a person committed an offense. Tappan argued, however, that sociological constructs such as antisocial behavior, conduct norms, and deviance fail to differentiate criminal versus noncriminal. In other words, in a more legalistic approach, Tappan believed that only people convicted of crimes with specific penalties could be considered criminals.

Q80. [Essay]

Explain how the three main components of the criminal justice system work together.

Suggested answer: Sample response: The three main components of the criminal justice system are law enforcement, courts, and corrections. Law enforcement agencies investigate crimes and arrest individuals who could have committed crimes. The courts interpret and apply the law to the criminal cases presented before them. Corrections work with convicted people who are reintegrating into society. Corrections function is to ensure public safety by working with probation or parole to have people who are incarcerated monitored and involved in community-based programs. The three components work together in various ways. For example, law enforcement investigates crimes and arrests people to send to the court system. They also assist corrections in locating and monitoring people who are incarcerated on parole. The court system receives people who have been arrested and puts them through the trial process. Many people who are incarcerated will accept a plea deal of probation and be placed with corrections for help with housing, work, and monitoring. A small population will go to trial and have their case be decided by a judge or jury. If a not guilty verdict is returned, the person is out of the criminal justice system. If a guilty verdict is returned, the person will be placed with corrections. Corrections' goal is to rehabilitate people so that they will not have to be incarcerated again. Some will serve time in prison, others will be allowed to live in the community under rules dictated by the court. These rules are known as terms of probation. Corrections monitors these people to ensure that they are abiding by the terms of their judicial sanction. Some people who are in prison will be paroled after serving a portion of their sentence. These paroled persons will work with corrections to meet the terms and conditions of their parole. If someone violates their probation or parole, corrections will work with law enforcement to find that person and bring them back to the court system.

Q81. [Essay]

Explain the concept of infotainment. How does it affect the public perception of the criminal justice system?

Suggested answer: Sample response: Infotainment is the marketing of a highly edited and distorted combination of entertainment and information purported to be truthful and comprehensive. Infotainment often distorts and sensationalizes the news to keep viewers interested in the particular media outlet. As much of the information presented is often framed to appeal to the target audience, people may be misinformed about criminal justice issues. To further complicate matters, media outlets often engage in narrow-casting, a practice that means viewers may only be introduced to content that reinforces their existing beliefs regarding the criminal justice system. Many are unaware that the media does not necessarily intend to inform viewers about newsworthy items, but rather to deliver a captive audience to advertisers. As such, infotainment may distort the public perception of the criminal justice system and cause people to focus on marginal or rare incidents, while overlooking more serious and pressing issues.

Q82. [Essay]

Explain the principles of the nonintervention perspective. Analyze the potential benefits and drawbacks of using this perspective.

Suggested answer: Sample response: The nonintervention perspective advocates for the legalization of victimless crimes, non-serious offenses, and a common-sense approach to criminal justice. Crimes like prostitution, possession/use of marijuana, gambling, and public drunkenness should be decriminalized. Advocates of this perspective argue that these crimes do not hurt anyone other than the person who is incarcerated and in a free society, consenting adults should be allowed to do whatever they like to themselves. The nonintervention perspective also advocates for the release of nonviolent persons. This approach aims to reduce criminal justice interventions by the state, minimizing the negative impacts of the correctional system. However, a drawback is that it overlooks the need for accountability among people who have broken the law.

Q83. [Essay]

Imagine that a homeowner uses force to defend their property after someone had broken into their home. Given the evolution of the castle doctrine over the past few decades, how might the homeowner's actions be interpreted?

Suggested answer: Sample response: Traditionally, when a resident was faced with a burglar entering their home who posed a threat to the resident, they had a duty to retreat before they could resort to using force to confront the intruder. Many jurisdictions felt this was unjust and developed what came to be known as the castle doctrine. Essentially, the castle doctrine removed the duty to retreat and allowed residents to use force, including deadly force, when appropriate, to repel the threat posed by the intruder. Different jurisdictions apply the doctrine in different ways. For example, some states apply the castle doctrine to the home, business, motor vehicle, public places, or any other place the individual has a right to be; others limit the protection afforded by the castle doctrine to the home. Under current legal standards, the homeowner's interpretation could support their defense by affirming their right to protect their property and personal safety.

Q84. [Essay]

The USA PATRIOT Act was passed in response to the attacks of September 11, 2001. Some people would argue that the USA PATRIOT Act is an infringement of inalienable rights which are protected by the U.S. Constitution. Discuss what inalienable rights are and how the USA PATRIOT Act possibly infringes on those rights.

Suggested answer: Sample response: An inalienable right is a universal right that is not contingent on the laws and is not specific to a particular government or culture. In the United States, these inalienable rights are protected by the Constitution. Some would argue that several provisions of the USA PATRIOT Act violate our Constitutional rights, specifically provisions that reduce restrictions on intelligence gathering and broadened discretion in detaining and deporting immigrants suspected of engaging in terrorist activities. In addition, the PATRIOT Act allowed for wiretaps, searches of business records, and surveillance of individuals with no ties to a particular terrorist group. It also allowed the FBI to monitor phone calls, emails, and financial records without the added safeguard of securing a search warrant. These powers are viewed by many as an overextension of the power of federal law enforcement agencies and a violation of our inalienable rights.

Q85. [Essay]

What is narrow-casting? Evaluate its effects on society's view of crime and people who are incarcerated.

Suggested answer: Sample response: Years ago, there were only a few news outlets and they had to appeal to a broad audience; as such, they tended to limit overt bias in presenting the news. As there are now many more media outlets covering the news, the outlets tend to cater to the demands of smaller, more homogenous audiences. This means that media outlets often present a narrow view of information aimed at appeasing their target audience, often at the expense of the truth. This practice, known as narrow-casting, can affect how certain segments of the population view crime and can perpetuate false beliefs about crime and criminals.

Discuss how the definitions of crime can change over time. Use the example of drunk driving to illustrate this phenomenon.

Suggested answer: Sample response: The definitions of crime change as societal understandings of the behavior change. In some situations, crimes become viewed as less problematic and are decriminalized. In other situations, they are viewed as increasingly criminal. For instance, drunk driving was initially seen as a personal problem, and people convicted of it rarely received jail time. In the 1970s, however, this changed, especially with the creation of Mothers Against Drunk Driving (MADD). MADD was started to persuade legislators to change the laws regarding driving under the influence, and drunk driving was seen as an increasingly unacceptable act.

Q99. [Essay]

Discuss the types of crimes that are considered victimless crimes. Are they truly victimless? Explain your answer.

Suggested answer: Sample response: Victimless crimes are criminal offenses that are thought not to involve victims because they do not directly harm individuals other than the people who are incarcerated. Examples of victimless crimes include prostitution, drug use, and gambling. For example, drug use may increase rates of burglary as users attempt to gain more resources to continue their habit. Prostitution may increase violence because these women and men are frequently assaulted as a result of their status. Prostitution also may be directly responsible for the trafficking of minors, as meeting the demand of clients (criminal offenders) requires the control of increasingly younger people forced into the sex trade. Gambling may lead to financial ruin, requiring families to be supported through governmental programs. Accordingly, many would argue that there is no such thing as victimless crime as these activities often harm society, as well as the people who are incarcerated.

Why is the understanding of public policy helpful in our understanding of criminal justice?

Suggested answer: Sample response: Public concerns shape legislation, policy, actions, and community standards. Understanding the needs of the community on issues such as gun violence, gangs, drug use, and other issues determine how our criminal justice system reacts. If a community views an issue, like gang violence, as pressing, the criminal justice system will focus on this issue, regardless of whether it is really the most important issue facing the system. Politicians want to show the community they are listening to them and responding to their concerns, so they can get elected or reelected.
