Briefly explain the difference between the crime control model and the due process model.

Suggested answer: Sample response: The crime control model emphasizes community protection from criminals, whereas the due process model is more concerned with the integrity of the legal process and gives great importance to the rights of the accused.

Q72. [Essay]

Compare and contrast the rehabilitation and reintegration goals of punishment.

Suggested answer: Sample response: The term rehabilitation means to restore or return to constructive or healthy activity. The rehabilitative goal is based on a medical model that is used to view criminal behavior as a moral sickness requiring treatment. Today, this model views criminality in terms of “faulty thinking” and criminals as in need of “programming” rather than “treatment.” The goal of rehabilitation is to change offenders’ attitudes so that they come to accept that their behavior was wrong, not to deter them by the threat of further punishment. The goal of reintegration is to use the time criminals are under correctional supervision to prepare them to reenter (or reintegrate with) the free community as well equipped to do so as possible.

Evaluate Beccaria’s views on crime and punishment. Do you believe his three components of effective punishment are adequate?

Suggested answer: Sample response: Beccaria is considered the leader of the Classical School. He believed that punishment should be just and reasonable, identical for identical crimes, and applied without reference to the social status of either the offender or the victim. For punishment to be affective, Beccaria argued that it must be certain, swift, and severe, and render a judgment on the value of these components. While this makes sense in theory, in practice it seems to be unattainable, as many crimes go unpunished (rendering “certainty” almost impossible), and many serious crimes, such as murder, can take years to fully resolve in the court system.

Suggested answer: Sample response: The principle behind deterrence is that people are deterred from crime by the threat of punishment. Punishing offenders serves as an example of what may happen if we violate the law.

Suggested answer: Sample response: Specific deterrence refers to the effect of punishment on the future behavior of persons who experience it. General deterrence refers to the preventive effect of the threat of punishment on the general population. They differ in at whom they are aimed.

Identify and discuss the four major justifications for punishment. Which do you agree with most?

Suggested answer: Sample response: Retribution is the oldest justification for punishment. It utilizes the ‘just deserts’ model whereby the punishment should fit the crime—offenders get what they justly deserve, and the punishment itself is justification enough. The second justification is deterrence, which posits that people will be deterred from committing a criminal act if they fear punishment from committing said act, is aimed at preventing crime from occurring in the first place. The third justification is incapacitation, which is a philosophy of punishment referring to how criminals cannot harm people on the streets when they are behind bars. The final major justification for punishment is rehabilitation. Rehabilitation aims to change the attitudes and behavior of offenders so they will be less apt to commit crimes in the future. I believe that deterrence is the best justification for punishment. It is a proactive justification that, if implemented effectively, can better protect a community from crime occurring in the first place.

Suggested answer: Sample response: Garofalo was a positivist who believed that, because human action is often evoked by circumstances beyond human control, the only thing to be considered at sentencing is the offenders’ “peculiarities,” or risk factors for crime. He identified various three types of criminals: extreme, impulsive, and endemic.

Suggested answer: Sample response: Durkheim argued that punishment functions to reaffirm social norms. Durkheim described two forms of justice: retributive justice (driven by desire for revenge) and restitutive justice (driven by deterrence). For the most part, the United States operates under a restitutive justice model. Crimes are considered against the state not the individual, so the focus is on protecting society from future crime rather than taking revenge for personal wrongs. Although the United States tries to emphasize restitutive justice, humans have a strong desire for revenge that can also be seen.

Imagine you are a candidate for political office. You are asked to give a short speech on crime. Choose either the crime control model or the due process model and write a short speech as though you are advocating for the implementation of this model.

Suggested answer: Sample response: Under the due process model, the rights of the accused are protected, and the law is followed because that is what is fair. It is better to have a guilty person go free every once in a while than have an innocent person wrongly convicted. Anyone could be charged with a crime and should treat others as we would want to be treated were we in that position. Everyone in a society must play by the rules, including and especially members of the criminal justice system. Only then are all people truly protected.

Jeremy Bentham once wrote, "Nature has placed mankind under the governance of two sovereign masters, pain and pleasure." Explain how this relates to the hedonistic calculus.

Suggested answer: Sample response: Bentham introduced the principle of utility, but his comment on pain and pleasure also relates to the hedonistic calculus, which humans are posited to use when weighing the potential benefit of a criminal activity with the expected consequences of that activity.
