Suggested answer: Sample response: Police are expected to 1) reduce crime and maintain order, 2) reduce the fear of crime, 3) solve neighborhood problems and improve the quality of life, and 4) develop greater community cohesion.

Why do you think specialized police forces are necessary?

Suggested answer: Sample response: Special purpose police provide necessary services that would be difficult for a standard police officer to provide in the course of their duties. For instance, ensuring the safety of a university campus is a full-time job that would take a standard police officer away from responding to calls for service in the rest of the town.

Describe the key differences between state police officers and federal agents.

Suggested answer: Sample response: Federal agents engage in different activities than state police officers. They tend to focus on investigations and control of federal crimes, while state police focus on state crimes.

List one example from the textbook that points to the changing landscape of policing.

Suggested answer: Sample response: More than half of a recent graduating class from the John Jay College of Criminal Justice in college consisted of women, suggesting more women are joining the police force.

Suggested answer: Sample response: The use of technology in policing has changed the way crimes are investigated and solved.

Suggested answer: Sample response: Having accurate data is required to hold police accountable. For instance, there is currently no official database on fatal shootings by police. This lack contributes to distrust of police among the public.

Explain the challenges associated with modifying job definitions in policing to include the emotional aspects of policing.

Suggested answer: *Sample response: Historically law enforcement has been a white male-dominated field that has focused on crime fighting. Policing practices have evolved to include the importance of emotions and feelings associated with the service aspects of the profession. Being sure to update the job definitions could encourage more women and people of color to apply for these positions. The inclusion of female officers and officers of color in the workforce has allowed for law enforcement to better handle certain aspects of policing and have decreased the idea of the us vs them mentality.*

Explain how the defining principles of the United States influence the ways police are expected to operate.

Suggested answer: *Sample response: All citizens in the United States are granted rights and these rights dictate how the police are expected to operate. Part of policing is to maintain order. However, in order to do this, the police have to work within the confines of protecting individual rights. Police are required to work within the restrictions on police activities that might violate our fundamental constitutional rights.*

Suggested answer: Sample response: Private security (a bouncer) would be most likely to respond to a college student drinking underage in a bar. University police may also remove the student from the bar. It is also possible that municipal police would respond and detain or arrest the student for drinking underage, which is a status offense.

Q97. [Essay]

If you were on a boat, drinking beer while under the age of 21, and fishing in the middle of the Florida swamp, under whose jurisdiction would you fall? Explain.

Suggested answer: Sample response: Most likely I would fall under the jurisdiction of a conservation police officer or a game warden. These officers enforce fish and wildlife laws, drug laws, and vehicle laws, all of which would apply in this situation.

Explain the potential consequences of a police officer who does not act ethically, honorably, and professionally.

Suggested answer: Sample response: There are several consequences of a police officer not acting ethically, honorably and professionally. There is a great deal of public scrutiny and outcry in these cases. Officers might face termination or even criminal charges. Additionally, law enforcement agencies around the country suffer from public distrust and a tarnished reputation.

In what ways do police officers' responsibilities vary between settings?

Suggested answer: Sample response: Police have several responsibilities. They are responsible for protecting the community while at the same time protecting individual rights. They must meet the expectations of their department as well as the communities they serve. Additionally, they are required to intervene in a variety of social service functions such as domestic violence, individuals with mental or emotional disturbances, and child and elder abuse.

The text notes that most police departments are struggling financially, attempting to figure out how to make their budgets stretch further. Should these police departments spend limited funding on hiring more officers, providing more training to existing officers, or updating dated equipment? Explain your reasoning.

Suggested answer: Sample response: Ideally all law enforcement agencies could build a budget that would allow for the hiring and training of more officers as well as updating dated equipment. However, realistically, many agencies have to make choices as to where their funding goes. I believe a police department is built on the people who make it up, so I think hiring and training officers should take precedence over updating dated equipment. Although this equipment might make investigations and solving cases easier, it is ultimately the officers on the force who dictate whether a police department is effective.
