Discuss one of Peel's principles of policing and how it mirrors goals in community policing today.

Suggested answer: Sample response: The Metropolitan Police focused on relationships with the community. Their ability to be successful was dependent on having a relationship with the community. This relationship with the community is also a focus of community policing today. Community oriented policing seeks to make police more visible in the community so that citizens see the police as working for them not against them. Community policing emphasizes that police can only be successful with the help of the community.

What was the role of slave patrols in the development of law enforcement in the United States?

Suggested answer: Sample response: Slave patrols were some of the earliest organized forms of policing in the United States. As the name implies, their role included patrolling for and capturing runaway slaves, but they could also chastise or even kill slaves they found off plantations. In the South, they served as a form of social control by enforcing the institution of slavery and prevented potential protests by slaves. In a time before formal law enforcement was established, slave patrols were the main form of formal control in the South.

How did an increase in research on policing lead to the end of the professional era of policing?

Suggested answer: Sample response: Research found that many myths about policing were unfounded. Things like two person cars did not improve officer safety or increase the chances of solving crime. Rapid response time and number of arrests were not good metrics for determining the effectiveness of policing. Police were focusing their limited time and resources on certain tasks because that was the way it had always been done. This research led police to rethink their practices and led to a shift away from professionalism and crime fighting back to community collaboration.

How did strategies of community policing compare to those used in the political and reform eras?

Suggested answer: Sample response: Community oriented policing meant a return to some of the strategies used in the political era, such as a return to foot patrol and an emphasis on knowing the communities and working with the community to solve problems that were important to residents. However, unlike the political era, police were hired for merit not political favors and police officers were trained before being sent out to patrol. Police were expected to behave professionally but to work with rather than against the people they served.

Discuss one type of crime that exists today that did not exist in the past and how police have changed to address this.

Suggested answer: Sample response: Cybercrime is a new type of crime that did not exist in the past. As technology has improved, offenders can now commit offenses like fraud and scams online. The offenders may now be in different jurisdictions or even different countries than the victims, which means that police have to collaborate with outside agencies. Additionally, police need specialized skills to investigate and combat crimes that are committed online to properly respond.
