Suggested answer: Sample response: The conflict perspective is based on the view that society is characterized by competition over money, power, and values. Society is shaped like a pyramid, with the wealthy and the powerful at the top and the mass of people near or at the bottom. The law is one tool used by the powerful to maintain their dominance and to attain their goals.

Suggested answer: Sample response: There are three areas that make up public law. First is criminal law and criminal procedure. This area focuses on how to define criminal conduct as well as the punishment of crimes and the procedures for the investigation and detection of crime. Second is constitutional law focuses. This area emphasizes the structure and functioning of the branches of government, the interrelationship between the branches of government, and the limits of governmental power and the rights of individuals. Third is administrative law, which governs the authority of government to regulate various activities. This type of law centers around agencies that are used to regulate virtually every aspect of society, including consumer protection, the conduct of elections and taxation.

Suggested answer: Sample response: Private law includes three areas, including contract, torts, and property. Contract law focuses on the formation and enforcement of agreements between individuals and between organizations. Tort law addresses rights and remedies for injuries to the person, property, privacy, reputation, and mental health of individuals. Finally, the law of property defines what is property, who owns property, and what the rules are for resolving ownership disputes. Additionally, there are other areas that can be considered private law, including , corporate law, family law, and copyright and patent law.

Suggested answer: *Sample response: Mores and folkways are types of informal norms. Mores are deeply held thoughts about what is right and wrong and folkways are customs that guide our behavior. Both of these often provide a foundation for what laws we put in place. An example of a more that influences law is our belief about the wrongness of taking an innocent person's life. Formal norms are laws or rules that can be enforced by external controls. This can be criminal laws that can be enforced by the government or suspending a student who faces consequences for cheating, behavior that breaks university policy.*

Compare and contrast the two perspectives on law and society.

Suggested answer: *Sample response: Law and society scholars tend to view the relationship between law and society through the lens of two opposing theoretical perspectives. The consensus perspective views society as a relatively stable entity where individuals share common values. Under this perspective, law is used to resolve the occasional disputes that may arise and serves to keep society stable and balanced. The contrasting view is the conflict perspective. Under the perspective, conflict is viewed as a central aspect of society. This view argues that society is composed of competing groups, and the law is an instrument of coercion that is employed by dominant and powerful groups to maintain their power and control.*
