Chapter 1

An Introduction to Drug Use

Chapter Summary

There's something in the human central nervous system (CNS) that motivates humans to seek the altered states of consciousness. Not everyone seeks an altered state, but they all have the neurological wiring to achieve it. Human paleolithic ancestors foraged for food and hence encountered and consumed plant substances that had effects that were considerably different from food. Thousands of years ago, humans discovered that some of these substances altered the workings of the mind. Some societies subsequently found that such a transformation could assist the users in a spiritual quest. Others simply found the experience pleasant. But whatever the motive, it is clear that drugs are psychoactive, humans like to take drugs because of their psychoactive effects. Drugs also have side effects, some of which can be unpleasant, potentially harmful, or even lethal. Drugs can be defined both materially as well as socially. The various definitions of drugs focus on three relevant drug contexts: its medical utility, its illegality, and its psychoactivity. What drugs do depends on whether one looks at its short-term effects ("acute" effects) or the long-term effects ("chronic: effects). There is also a distinction between the effective dose of a drug as well as its lethal dose. Individuals who take drugs also become tolerant to its effects over time and need increasingly larger doses to achieve the same effect—known as drug Tolerance. The factors that influence drug action include the route of administration, dose, potency and purity, and drug mixing. Drugs are classified into different categories or types of substances according to their psychoactive effects. These categories are stimulant; depressants or sedative/hypnotics; opiates/narcotics; hallucinogens/psychedelics; marijuana/cannabis; ecstasy/MDMA; and dissociative anesthetics. The objective of this chapter is to explain how natural, inherent, chemical properties of substances influence what drugs do to the human mind and, hence, why and how they are taken. The perspectives on the study of human drug consumption can be divided into two categories: pathology orientation and the impartial, unbiased, or "objective" perspective. According to pathology researchers and commentators, drugs as recreation, by its very nature, constitutes abuse; it is unnatural, abusive, and medically risky, and should be avoided. To the impartial author or researcher, recreational drug use is not inherently or by its very nature "abuse." Only when getting high entails inappropriate or excessive use does it become "abuse."
