ANSWER: Mills described the sociological imagination as the ability to connect personal experiences with broader societal issues by revealing how larger social forces shape individual problems. For example, if someone is laid off, they might blame themselves. However, using the sociological imagination, they would recognize their unemployment might be a consequence of an economic downturn, like the 2008 financial crisis, which affected millions of Americans. This approach distinguishes between personal troubles and societal issues, showing how economic policy or market conditions impact an individual beyond personal control. In contrast to the sociological imagination, other sociological perspectives (structural functionalism, conflict theory, symbolic interactionism) would approach these issues differently. Structural functionalists would focus on the effects of unemployment on social stability and the functions of institutions like employment agencies. Conflict theory emphasizes economic inequalities and how they contribute to unemployment and the struggles between differing socioeconomic groups. Symbolic interactionists might explore how

individuals make sense of their unemployment in personal terms, potentially overlooking broader societal impacts. By comparing these perspectives, we can appreciate the unique insights offered by the sociological imagination in connecting personal experiences with societal issues.

38. Explain how industrialization and urbanization motivated the emergence of sociology.

ANSWER: Industrialization and urbanization sparked massive economic, technological, and social changes that marks a transition from an agrarian to an industrial economy. This shift created a new social class of industrialists who dominated textile, iron smelting, and related industries. Many individuals who had previously lived in tightly knit rural communities were compelled to leave behind their well-defined social relationships and seek employment in the factories of rapidly growing cities. As cities became centers of industrial work, they transformed into melting pots of diverse populations interacting for the first time, leading to significant social changes central to the theories of sociologists like Simmel and Weber. Simmel highlighted how the fast pace and anonymity of urban life resulted in social fragmentation and alienation as individuals navigated the complexities of modern existence. In contrast, Weber focused on the implications of rationalization and bureaucracy, arguing that industrial capitalism replaced traditional ways of life with a focus on efficiency and productivity, altering social relationships and individual identities. This shift from producers to consumers, combined with inadequate housing, overcrowding, unsanitary conditions, and low wages, created numerous social problems. As these issues became more visible, they prompted Simmel, Weber, and other social thinkers to systematically study the complex dynamics of modern society and their effects on social relations and individual identity.

39. Briefly summarize the contributions of Harriet Martineau to early sociology and explain why she did not receive recognition for her work until recently.

ANSWER: British sociologist Harriet Martineau translated and condensed the works of Auguste Comte, bringing them to a wider audience. Perhaps more importantly, she studied the social customs of Britain and the United States, analyzing the consequences of industrialization and capitalism. In addition, she strongly advocated social change, encouraging greater racial and gender equality, and was committed to creating a science of society that would be grounded in empirical observations and widely accessible to people. Until fairly recently, Martineau received no recognition in the field of sociology, partly because she was a woman in a male-dominated discipline and society.

40. Explain what Herbert Spencer meant by “survival of the fittest.” What are the criticisms of his approach?

ANSWER: Spencer believed that societies develop through a process of “struggle” (for existence) and “fitness” (for survival), which he referred to as the “survival of the fittest.” Spencer’s view of society is known as social Darwinism—the belief that those species of animals, including human beings, best adapted to their environment survive and prosper, whereas those poorly adapted die out. Spencer equated this process of natural selection with progress because only the “fittest” members of society would survive the competition and the “unfit” would be filtered out of society. Critics say that he considered society similar to a biological system. Also, his idea of the survival of the fittest can be used to justify different kinds of inequalities.

41. Evaluate the relevance of Karl Marx's theory of class conflict in modern society. How would Marx’s theory of class struggle between the capitalist and working classes still apply today? Why?

ANSWER: Karl Marx’s theory of class conflict, emphasizing the clash between the bourgeoisie (the capitalist class) and the proletariat (the working class), remains a cornerstone in understanding historical and economic change. The theory remains relevant in modern society because of issues related to income inequality, labor exploitation, and the high concentration of wealth among the elite. Though labor has evolved with globalization and technology, conflict between the bourgeoisie and the proletariat still persists. For example, large business influence over political power and the rising gap between executive employees and the average worker reflects Marx’s philosophy on class struggle. His theory is applicable in modern society as it explains how power imbalance and economic disparity influence capitalist society.

ANSWER: Functionalist perspectives are based on the assumption that society is a stable, orderly system. This stable system is characterized by societal consensus, whereby the majority of members share a common set of values, beliefs, and behavioral expectations. A society is composed of interrelated parts, each of which serves a function and (ideally) contributes to the overall stability of the society. Societies develop social structures, or institutions that persist because they play a part in helping society survive. These institutions include the family, education, government, religion, and the economy. If anything adverse happens to one of these institutions or parts, all other parts are affected, and the system no longer functions properly. The functionalist perspective focuses primarily on a macrolevel analysis. A macrolevel analysis examines whole societies, large-scale social structures, and social systems instead of looking at important social dynamics in individuals' lives.

On the contrary, the symbolic interactionist perspective is based on a microlevel analysis, which focuses on small groups rather than large-scale social structures. According to this perspective, society is the sum of the interactions of people and groups. Behavior is learned in interactions with other people; how people define a situation becomes the foundation for how they behave.

43. State the major assumptions of the conflict perspectives of sociology. How can a conflict approach be used to explain suicide?

ANSWER: According to conflict perspectives, groups in society are engaged in a continuous power struggle for control of scarce resources. Conflict may take the form of politics, litigation, negotiations, or family discussions about financial matters. Today, advocates of the conflict perspective view social life as a continuous power struggle among competing social groups. The conflict perspective encompasses the following branches: (1) the neo-Marxist approach, which views struggle between the classes as inevitable and as a prime source of social change; (2) the branch that focuses on racial-ethnic inequalities and the continued exploitation of members of some racial-ethnic groups; and (3) the feminist approach, which focuses on gender issues. Conflict perspectives state that social-class pressures may affect rates of suicide among young people from lower-income families when they perceive that they have few educational or employment opportunities and little hope for the future. Feminist analysts employing a conflict perspective believe that social structural pressures on young women, such as cultural assumptions about women and what their multiple roles should be in the family, education, and the workplace, may contribute to suicide. Other conflict approaches suggest that racial and ethnic subordination may be a factor in some suicides.

44. State the major assumptions of the symbolic interactionist perspectives of sociology. Explain how this perspective differs from the conflict perspective of sociology.

ANSWER: According to symbolic interactionist perspectives, society is the sum of the interactions of individuals and groups. Symbolic interactionists focus on the process of interaction—defined as immediate, reciprocally oriented communication between two or more people—and the part that symbols play in giving meaning to human communication. Symbolic communication occurs in a variety of forms, including facial gestures, posture, tone of voice, and other symbolic gestures (such as a handshake or a clenched fist). In social encounters, each person's interpretation or definition of a given situation becomes a subjective reality from that person's viewpoint. Symbolic interactionists attempt to study how people make sense of their life situations and the way they go about their activities, in conjunction with others, on a day-to-day basis. The symbolic interactionist perspective is based on a microlevel analysis, which focuses on small groups rather than large-scale social structures. On the contrary, the conflict perspective focuses primarily on a macrolevel analysis. A macrolevel analysis examines whole societies, large-scale social structures, and social systems instead of looking at important social dynamics in individuals' lives.

45. Explain how the steps in the qualitative research model differ from the steps in the "conventional" quantitative model.

ANSWER: The underlying logic involved in both quantitative and qualitative sociological research is the same, but the styles of these two models are very different. In a quantitative approach, the researcher reviews previous

research on the research problem, develops a hypothesis if the study is explanatory, and then develops the research design. On the contrary, in a qualitative approach, reviewing the literature and developing the research design often happen simultaneously. Typically, the next step in both these models is collecting and analyzing data to assess the validity of the starting proposition. Data gathering is the foundation of research. As compared to a quantitative model, a qualitative approach often involves a smaller number of cases. Researchers pursuing a qualitative approach tend to gather data in natural settings, such as where the person lives or works, rather than in a laboratory or other research setting, which is the case in a quantitative approach. In a qualitative approach, data collection and analysis frequently occur concurrently, and the analysis draws heavily on the language of the persons studied, not the researcher. In a quantitative approach, data collection and analysis occur sequentially; researchers first collect data and then analyze them. Once these steps are completed, the next step in both these models involves drawing conclusions from the research and reporting the findings to others.

46. Explain the process of conducting an experiment. Then, discuss the advantages and disadvantages of experiments as a research method. Describe how experiments can be used to demonstrate a cause-and-effect relationship between video games and an increase in violent tendencies in people who use them.

ANSWER: An experiment is a carefully designed situation in which researchers study the impact of certain variables on subjects' attitudes or behaviors. An experiment has an experimental group, which is exposed to the independent variable, and a control group, whose subjects are not exposed to the independent variable. A major advantage is the experimenter's control of the process; the greatest limitation is that the experiment is artificial—the behavior takes place in an artificially created situation.

Researchers may use experiments when they want to demonstrate that a cause-and-effect relationship exists between variables, such as whether violent video games (the independent variable) cause an increase in violent tendencies in people who use them (the dependent variable). To show that a change in the independent variable causes a change in the dependent variable, three conditions must be satisfied: (1) A correlation between the two variables must be shown to exist (correlation exists when two variables are associated more frequently than could be expected by chance); (2) the independent variable must have occurred prior to the dependent variable; and (3) any change in the dependent variable must not have been caused by an extraneous variable—one outside the stated hypothesis.

ANSWER: Researchers are required to obtain written "informed consent" statements from the persons they study. The American Sociological Association's *Code of Ethics* sets forth certain basic standards that sociologists must follow in conducting research. These standards are as follows: (1) Researchers must endeavor to maintain objectivity and integrity in their research by disclosing their research findings in full and including all possible interpretations of the data (even those interpretations that do not support their own viewpoints); (2) researchers must safeguard the participants' right to privacy and dignity while protecting them from harm; (3) researchers must protect confidential information provided by participants, even when this information is not considered to be "privileged" (legally protected, as is the case between doctor and patient and between attorney and client) and legal pressure is applied to reveal this information; and (4) researchers must acknowledge research collaboration and assistance they receive from others and disclose all sources of financial support. Sociologists are obligated to adhere to this code and to protect research participants. In the twenty-first century, some researchers have called attention to the ethics of suicide research. These ethical problems include how to maintain the confidentiality of research participants, as well as how to respond in a sensitive and supportive manner to meet their needs (Lakeman and Fitzgerald, 2009). When studies of suicides are conducted to provide better insights on how to reduce rates of suicide, these ethical concerns are important in all stages of the research process.

PURPOSE AND PERSPECTIVE OF THE CHAPTER

The purpose of this chapter is to introduce the fundamental aspects of sociology and its research methods. It begins by defining sociology and the sociological imagination, emphasizing their importance in understanding social life from a global perspective. The chapter explores sociology's historical development, from early thinkers' focus on social order to later concerns with social change. It examines major theoretical perspectives – functionalist, conflict, symbolic interactionist, and postmodern – showing how each uniquely approaches social analysis. The chapter then demonstrates the value of sociological research in challenging common assumptions about social issues, explaining both quantitative and qualitative methodologies. It outlines four main research methods: surveys, secondary analysis, field research, and experiments. Finally, it addresses the ethical considerations and professional standards that govern sociological research to protect participants.

KEY TERMS

Anomie: Emile Durkheim's term for a condition in which social control becomes ineffective as a result of the loss of shared values and of a sense of purpose in society.

Conflict perspectives: The sociological approach that views groups in society as engaged in a continuous power struggle for control of scarce resources.

Content analysis: The systematic examination of cultural artifacts or various forms of communication to extract thematic data and draw conclusions about social life.

Control group: The group that contains the subjects who are not exposed to the independent variable.

Correlation: A relationship that exists when two variables are associated more frequently than could be expected by chance.

Dependent variable: In an experiment, the variable assumed to be caused by the independent variable(s).

Ethnography: A detailed study of the life and activities of a group of people by researchers who may live with that group over a period of years.

Experiment: A carefully designed situation in which the researcher studies the impact of certain variables on subjects' attitudes or behavior.

Experimental group: The group that contains the subjects who are exposed to an independent variable (the experimental condition) to study its effect on them.

Functionalist perspectives: The sociological approach that views society as a stable, orderly system.

High-income countries: Nations with highly industrialized economies; technologically advanced industrial, administrative, and service occupations; and relatively high levels of national and personal income.

Hypothesis: A statement of the expected relationship between two or more variables.

Independent variable: In an experiment, the variable assumed to be the cause of the relationship between variables.

Industrialization: The process by which societies are transformed from dependence on agriculture and handmade products to an emphasis on manufacturing and related industries.

Interview: A data-collection encounter in which an interviewer asks the respondent questions and records the answers.

Latent functions: Unintended functions that are hidden and remain unacknowledged by participants.

Low-income countries: Primarily agrarian nations with little industrialization and low levels of national and personal income.

Macrolevel analysis: An approach that examines whole societies, large-scale social structures, and social systems instead of looking at important social dynamics in individuals' lives.

Manifest functions: Functions that are intended and/or overtly recognized by the participants in a social unit.

Microlevel analysis: An approach that focuses on small groups rather than large-scale social structures.

Middle-income countries: Nations with industrializing economies, particularly in urban areas, and moderate levels of national and personal income.

Participant observation: A research method in which researchers collect systematic observations while being part of the activities of the group being studied.

Positivism: A belief that the world can best be understood through scientific inquiry.

Postmodern perspectives: The sociological approach that attempts to explain social life in contemporary societies that are characterized by postindustrialization, consumerism, and global communication.

Qualitative research: Sociological research methods that use interpretive descriptions (words) rather than statistics (numbers) to analyze underlying meanings and patterns of social relationships.

Quantitative research: Sociological research methods based on the goal of scientific objectivity; they focus on data that can be measured numerically.

Questionnaire: A printed research instrument containing a series of items to which subjects respond.

Reliability: The extent to which a study or research instrument yields consistent results when applied to different individuals at one time or to the same individuals over time.

Research methods: Specific strategies or techniques for systematically conducting research.

Secondary analysis: A research method in which researchers use existing material and analyze data that were originally collected by others.

Social Darwinism: Herbert Spencer's belief that those species of animals, including human beings, best adapted to their environment survive and prosper, whereas those poorly adapted die out.

Social facts: Emile Durkheim's term for patterned ways of acting, thinking, and feeling which exist outside any one individual but exert social control over each person.

Society: A large social grouping that shares the same geographical territory and is subject to the same political authority and dominant cultural expectations.

Sociological imagination: C. Wright Mills' term for the ability to see the relationship between individual experiences and the larger society.

Sociology: The systematic study of human society and social interaction.

Survey: A poll in which the researcher gathers facts or attempts to determine the relationships among facts.

Symbolic interactionist perspectives: The sociological approach that views society as the sum of the interactions of individuals and groups.

Theory: A set of logically interrelated statements that attempts to describe, explain, and (occasionally) predict social events.

Urbanization: The process by which an increasing proportion of a population lives in cities rather than in rural areas.

Validity: The extent to which a study or research instrument accurately measures what it is supposed to measure.

Variable: Any concept with measurable traits or characteristics that can change or vary from one person, time, situation, or society to another

ADDITIONAL DISCUSSION QUESTIONS

The following are discussion questions that do not appear in the text, PPTs, or courseware – they are for you to use as you wish. You can assign these questions several ways: in a discussion forum in your LMS; as whole-class discussions in person; or as a partner or group activity in class.

1. Discussion: Origins of Sociology, Duration 30 minutes.

This discussion aims to help students understand the development of sociological thinking and early social thinkers.

- a. Why did rapid industrialization and urbanization lead to the development of sociological thinking?
 - i. Answer: Industrialization transformed society from dependence on agriculture and handmade products to an emphasis on manufacturing and related industries, while urbanization increased the proportion of the population that lives in cities rather than in rural areas.
- b. What current events have the ability to influence the development of sociological thinking today? How?
 - i. Answer: Answers will vary. However, students may mention the COVID-19 pandemic, the Russian invasion of Ukraine, climate change, the Black Lives Matter movements, student loan debt, technology (Metaverse), etc.

2. Discussion: Functionalist Perspectives, Duration 10 minutes.

This discussion allows students to apply functionalist perspectives to colleges and universities.

- a. What are the manifest functions of colleges and universities?
 - i. Answer: Providing students with an intellectual framework, imparting practical skills, and conveying society's values.
- b. What latent functions do colleges and universities perform?
 - i. Answer: Socialization with peers and conformity to norms.

3. Discussion: The Beginnings of Sociology in the United States, Duration 20 minutes.

This discussion helps students understand the key figures in early American sociology and their main ideas.

- a. Compare and contrast the approaches of Jane Addams and W.E.B. Du Bois in addressing social issues.
 - i. Answer: Jane Addams founded Hull House to help economically disadvantaged people in Chicago and focused on practical social work. W.E.B. Du Bois focused on research about Black communities and created the concept of double-consciousness (being both Black and American).
 - b. Which social problems studied by early sociologists still exist today? Give examples.
 - i. Answer: Answers may include urban poverty, racial discrimination, social inequality, community problems in cities.
4. Discussion: Conducting Quantitative Research, Duration 30 minutes.
This discussion helps students understand the basic steps of conducting quantitative research in sociology.
 - a. What are the steps in the sociological research process using a deductive approach which aligns well with quantitative research?
 - i. Answer:
 1. Select and define the research problem
 2. Review previous research
 3. Formulate the hypothesis (if applicable)
 4. Develop the research design
 5. Collect and analyze the data
 6. Draw conclusions and report the findings
 - b. What is the difference between dependent and independent variables? Give an example.
 - i. Answer: The independent variable is presumed to be the cause of the relationship; the dependent variable is assumed to be caused by the independent variable(s). For example (answers may vary):
 - Independent variable: amount of study time
 - Dependent variable: test scores
5. Discussion: Survey Research Methods, Duration: 20 minutes.
This discussion helps students understand different types of surveys and their applications in sociological research.
 - a. What are the main types of surveys and what are their key characteristics?
 - i. Answer:
 1. Self-administered questionnaires (mailed, online, or group administered)
 2. Face-to-face interviews (structured interviews with standardized questions)
 3. Telephone/computer surveys (like Gallup World Poll)
 - b. Why are surveys the most widely used research method in social sciences? What can they measure that other methods cannot?

i. Answer:

- They can study things not directly observable (attitudes and beliefs).
- They can describe large populations through representative samples.
- They allow researchers to collect standardized data.
- They can reach diverse populations across different locations.

ADDITIONAL ACTIVITIES AND ASSIGNMENTS

The following are activities and assignments developed by Cengage but are not included in the text, PPTs, or courseware – they are for you to use if you wish.

1. **Sociology as science:** Explain the difference between common-sense knowledge and what we know to be true because of scientific research. The text uses the example of suicide throughout Chapter 1.
 - a. Bring in copies of the “How Much Do You Know about Suicide?” quiz from this chapter. Instead of having students take the quiz individually, have them do so in small groups.
 - b. To prevent students from working as individuals, give each group a single quiz. This method gets students talking with each other about the subject matter and talking through ideas. Students may be hesitant at first to take part in a discussion with you.
2. **The sociological imagination:** Search news sources on the Internet in class and use some of these as a springboard for your presentation of C. Wright Mills’ ideas about the **sociological imagination**.
 - a. Find stories that seem to relate news about personal problems such as family, crime, employment, and education.
 - b. You may have to help your students work backward to determine how these stories reflect personal troubles.
 - c. What are the social issues involved? Challenge your class to engage in big-picture thinking.
3. **Social facts:** Help students understand the nature and power of social facts. Brainstorm with students and come up with a list of social facts. Next, address these questions:
 - a. What did individuals do to create this social fact?
 - b. How does this fact affect the way that people behave and think?
 - c. How does this fact affect the way I behave and think? What causes social facts to change?

VIDEO SUGGESTIONS

The Bridge (94 minutes)

Over the span of a year, cameras capture tormented souls trying to kill themselves by leaping from San Francisco's Golden Gate Bridge. This provocative documentary underscores the landmark's reputation as the world's most popular suicide destination. Through poignant interviews with family, friends, and eyewitnesses, director Eric Steel's film reveals a common thread of depression, despair, and chronic mental illness (<http://www.thebridge-themovie.com>).

Gosford Park (138 minutes)

This is a great film that demonstrates the stark class distinctions that persist in other parts of the world. The film will help students understand the kind of world that Marx was addressing as he developed his grand theory. There are several excellent clips you can discuss with students; or you can assign the film for extra credit. Watch it yourself before your presentation about social theories.

Guns, Germs, and Steel (180 minutes; National Geographic Video)

Showing clips from this video, which is based on the bestselling book by the biologist Jared Diamond, can help you explain social evolution (Spencer) and the impact of industrialization and urbanization on the development of world civilizations. Your university library may have access to this film.

Baraka (97 minutes)

This is an incredible and stunning visual tour de force of cultures from around the world. It's a great way to introduce students to the concept of "big picture thinking." Show the whole film for a huge impact, or show bits and pieces (you can present additional clips during your study of culture, in Chapter 2). This film is widely available for purchase or rental.

Les Misérables (159 minutes)

Show the whole film or just excerpts to capture the mood of the Industrial Revolution across Europe. This film helps you show students the historical context of thinkers like Comte, Marx, and Spencer.

A Death of One's Own (88 minutes; Films for the Humanities and Sciences)

This film addresses issues related to personal control and physician-assisted suicide. Bill Moyers hosts interviews with three families and their doctors.

The Suicide Plan (83 minutes; Frontline)

This Frontline film explores the underground world of assisted suicide from the point of view of not only those choosing to die but also those people and organizations that assist them. (From the [PBS Frontline website.](#))

Karl Marx and Marxism (53 minutes; Films for the Humanities and Sciences)

This program looks at Marx, the roots of his philosophy, the explanations of his philosophical development, and the most direct outcome of his philosophy: the failed Soviet Union.
